

MINUTES OF THE CADRE REVIEW COMMITTEE MEETING

The meeting of the Cadre Review Committee was held under the Chairmanship of CE(D), DG:AIR on 29<sup>th</sup> June, 2011 at 3 PM. The following members of the Committee were present in the Meeting:-

The Minutes of the meeting are as under:-

- At the outset, Chairman welcomed the members and discussed the Cadre Review Committee Report submitted in May, 2009 by the then CE(D) to Prasar Bharati Secretariat.
- Chairman inquired from the representatives of ARTEE and ADTEA that what are their suggestions/view points which needs to be incorporated or amendments, if any, to be made in the Cadre Review Report. On this, the representatives of both ARTEE and ADTEA submitted that both the Associations will submit a joint proposal before the Committee in the next meeting. Representatives of both ARTEE and ADTEA submitted that there are certain issues relating to merger of cadres of Engineering Assistants and Senior Engineering Assistants after implementation of 6<sup>th</sup> Pay Commission. There are merger proposed in other cadres in the Cadre Review Committee Report, which needs to be redefined.
- Representatives of ARTEE and ADTEA demanded that since a Cadre Review Committee Report was for entire Engineering Cadres, right from IB(E)S to Subordinate Engineering Cadres, the representatives of ADEA (AIR Doordarshan Engineers Association) may also be called for the meeting. On this demand of Association, Chairman did not agree to the inclusion of ADEA representatives in the Committee, as the Committee has been formed by the Prasar Bharati Secretariat and the decision to include their representatives will be taken by the Competent Authority in Prasar Bharati Secretariat.
- Sh. Ved Narayan Jha, President, Akhil Bhartiya AIR Group D Karmchari Sangh, was invited in the Meeting by the convener as Ex-Officio Member of the Committee, representing Group D staff, as Sh. Jha was also a member of the previous Cadre Review Committee. Chairman did not agree to the inclusion of Sh. Jha as Ex-Officio Member of the Committee as Prasar Bharati Secretariat has not included his name in the Committee approved by them. Chairman suggested that Sh. Jha may take up the matter with Prasar Bharati Secretariat for inclusion of his name in the Cadre Review Committee.

At the end of the meeting, Chairman directed that the joint proposal proposed to be submitted by ARTEE and ADTEA, be submitted immediately so that 2<sup>nd</sup> meeting of the Committee may be immediately convened to discuss the issues.


The meeting ended with a vote of thanks to the chair.
