
ORDER No. 11 / 2011-S-IV(B)

In pursuance of DoP&T's O.M. No. 35034/3/2008-Estt.(D) dated 19th May, 2009, the Competent Authority has approved the **2nd Financial up-gradation on completion of 20 years of regular service or 10 years regular service in the grade of Assistant Engineer, whichever is earlier**, in respect of the following Assistant Engineers from the present Grade Pay of Rs. 4800/- to Rs. 5400/- in the Pay Band-II(Rs.9300-34800) under Modified Assured Career Progression Scheme(MACPS):-

- (i) to those Assistant Engineers, who have already completed 20 years service on or before 31.12.2010 &
- (ii) In other cases, 2nd financial upgradation will be available w.e.f. their actual date of completion of 10 years of service in the grade.


